Warranty Provision

If, for any reason, you are not completely satisfied, you may return your purchase within 30 days for a full refund. Tapes are sold for the life of the cassette, however, Coastal will gladly replace any tape that is damaged or proves defective within 12 months of purchase.

Government Commercial Credit Card

Coastal accepts the Government commercial credit card, however, we do not offer any discounts for its use, including prompt payment discounts.

Rentals

Most Coastal programs are available for rental. Weekly rental prices (commercial) are listed in this price list with individual programs. Government discount must be deducted from list prices. Rental charges may be applied to the purchase price if the program is purchased within 30 days.

Previews

Customers may schedule a 7-day preview of any program or compliance manual at no charge. Coastal reserves the right to limit quantities and to elect not to send previews. Previews are for evaluation only, and may not be used for training. By ordering previews, customers accept responsibility for returning the materials at their own expense.

Shipping

Most orders are shipped via UPS ground or U.S. Postal Service the day after they are received. Orders may be shipped via Second-Day Air, 3-Day Select, Next Day Air or Express Service for an additional charge. All orders are shipped FOB destination from Virginia Beach, VA. Previews and rentals should be returned via traceable shipping service, such as UPS, Federal Express or Registered Mail – Return Receipt Required. The customer is responsible for loss or damage on return shipments. For your protection, you may want to insure the package for full value. Failure to return previews and rentals via a traceable means could result in your organization being billed for the full purchase price.

Combining Products

Products within the same category (i.e. videotapes, CD-ROMs, DVDs, compliance training manuals and guides, illustrated employee handbooks or posters) can be combined to receive a quantity discount.

Program Updates
